## THE RECTOR

- **Having regard** to Rector's Decree Rep. n. 411-2019 Prot. n. 20540 dated May 17<sup>th</sup>, 2019, published in the Gazzetta Ufficiale n. 42 on May 28<sup>th</sup>, 2019 by which a selection procedure has been held to recruit **n.** 3 fixed-term (3 year) full-time Researchers in compliance with Art. 24, Par. 3, Letter b) of Italian Law 240/2010 at various Departments;
- Having regard to Paragraph 1, Art. 8 of the selection procedure announcement mentioned in the previous paragraph (entitled "Role and Duties of the Examining Board"), which reads: "In the first session the Board, having determined that in compliance with related laws, no incompatibility factors are present, outlines the preliminary assessment criteria and procedures for selection in compliance with the parameters indicated in Ministerial Decree n. 243, 25 May 2011, and the criteria and specific functions to be carried out by the Researcher.
  - The Board also establishes an analytical system to confer points to candidates after preliminary assessment has been completed. The Board then establishes which candidates are admitted to the interview, together with the criteria for testing their English language skills, and Italian language skills for foreign applicants";
- **Noted that** the sentence "... the criteria and specific functions to be carried out by the Researcher" is contrary to what is provided for in Art. 2 of the same announcement, entitled "Admission Requisites and Causes for Exclusion":
- **Considering** that it is necessary to correct the selection procedure issued with Rector's Decree n. 411-2019, Prot. n. 20540 dated May 17<sup>th</sup>, 2019;

## DECREES THE FOLLOWING

**Art. 1** – Paragraph 1, Art. 8 of Rector's Decree n. 411–2019 Prot. n. 20540 dated May 17<sup>th</sup>, 2019 is corrected as follows:

"In the first session the Board, having determined that in compliance with related laws, no incompatibility factors are present, outlines the preliminary assessment criteria and procedures for selection in compliance with the parameters indicated in Ministerial Decree n. 243, 25 May 2011.

The Board also establishes an analytical system to confer points to candidates after preliminary assessment has been completed. The Board then establishes which candidates are admitted to the interview, together with the criteria for testing their English language skills, and Italian language skills for foreign applicants";

**Art. 2** – The deadline for application submission is re-opened, according to what specified in Art. 3 of the selection procedure, for **10 days** from the day following publication of the announcement of the present corrigendum in the Gazzetta Ufficiale.
