#### **DECREES THE FOLLOWING:**

## Art. 1 - Public Selection, position available and objective of the contract

1.A public selection procedure is being held at the University of L'Aquila to recruit 3 fixed-term full-time researchers in compliance with Art. 24, Par. 3, Letter a) of Italian Law 240/2010 and related University Regulations;

- 2. Attachments A, B, C, form integral part of this selection announcement, indicating the research project title, the person in charge of the project, candidates' requisites for participation, research activity, teaching and support activities to be carried out by the selected researcher, foreign language requisite, maximum number of publications to be presented and required skills.
- **3**. The number of hours required for teaching and integrated activities is 350 hrs. per year. The total number of hours required for research, teaching and integrated activities is 1,500 hrs. per year.

#### **Art. 2 Admission Requisites**

1. The Selection Procedure is open to Italian, EU and non-EU citizens holding an Italian residency permit as per Leg. Decree 165/2001, Art. 38 and possessing the following qualifications:

Admission requisites must be held by applicants within the deadline for application submission.

- **2**. The following categories may not participate in this public selection procedure:
- a) First or second tier university professors or researchers already holding an openended contract.
- b) Individuals who have already held fixed-term research contracts as provided in Arts. 22 and 24 of Italian Law 240/10 at the University of L'Aquila or at other Italian Universities, whether public, private or online, or bodies under Par. 1 of Art. 22 of Italian law 240/2010 for a period, in addition to the intended duration of the competition contract, exceeding a total of 12 years, even if not continuing. Maternity or sick leave as provided in the laws in force shall not be included in the duration of the aforementioned employment contracts;
- c. Individuals not entitled to exercise civil and political rights;
- d. Individuals who have been dismissed or relieved from office with a Public Administration for consistently poor performance;
- e. Individuals who have been dismissed from a civil service job as provided in Art. 127, Letter d) of D.P.R. 10 **January**, 1957, No. 3;

- f. Individuals who are married or related, up to the fourth degree, to professors belonging to the recruiting Department including the Rector, General Director, any member of the Board of Directors as provided in Art. 18, Par. 1, Letter b) and c), of Italian Law 240/2010.

- 14. (**Non-Italian citizens**) That he/she has an adequate knowledge of the Italian language;
- 15. That he/she is aware that the examining board shall be nominated by Rector's Decree are published for at least seven days on the University's Albo Ufficiale and posted on the relevant page of the university website <a href="www.univaq.it">www.univaq.it</a>, in all effects representing official notice to the candidates participating.
- 16. That he/she is aware that a list of candidates admitted to the selection procedure is published for at least seven days on the University's Albo Ufficiale and posted on the relevant page of the university website <a href="www.univaq.it">www.univaq.it</a>, in all effects representing official notice to the candidates participating.
- 17. That he/she is aware that the assessment procedure adopted by the examining board in the first session and the interview dates are published for at least seven days on the University's Albo Ufficiale and posted on the relevant page of the university website <a href="www.univaq.it">www.univaq.it</a>, in all effects representing official notice to the candidates participating.
- 18. That he/she is aware that all documents related to the selection procedure together with decree of approval are published for at least seven days on the University's Albo Ufficiale and posted on the relevant page of the university website <a href="https://www.univag.it">www.univag.it</a>, in all effects representing official notice to the candidates participating.

#### **Art. 5 Publications**

1.The publications the candidate wishes to present must be placed in a separate envelope from the envelope containing their application form, whether they are being forwarded via certified mail (PEC), delivered by hand or mailed to Settore Concorsi e Selezioni – Via Giovanni Di Vincenzo, 16/B – 67100 L'AQUILA, within the specified deadline. Any mail arriving past the indicated deadline shall be discarded even if mailed before the deadline. The administration shall only accept applications and publications arriving at the University within the deadline, the stamp indicating the actual date it was sent will not be taken into consideration.

Publications submitted must be organized in the same order indicated in the numbered list the applicant must provide in the application, they can be submitted in original copy or scanned or uploaded on CD-Rom or DVD, in non-modifiable format. In any case they must be declared as conforming to original using the self-affidavit form (attachment 2) in which the candidate shall indicate the numbered list of publications presented and any element useful for correct identification.

- 2.The number of publications presented must comply with the maximum number indicated in the announcement (Attachments A,B,C,) if the candidate exceeds the maximum number indicated the Board shall consider them in order up to the number indicated in this selection procedure.
- 3. Candidates cannot make references to other publications/documents presented previously to the University of L'Aquila or to any other administration/institution.
- 4. The candidate must indicate the contents of the envelope by writing "publications" on it, also specifying their name, surname, mailing address for all selection procedure notifications, the name of the University issuing the selection procedure, the requesting Department, the academic recruitment field, academic discipline and the position being applied for.
- 5. Works published in Italy will be assessed if they comply with legal standards and are pursuant to Leg. Decree n.660/1945 as amended by Italian Law 106/2004 and Presidential Decree n. 252/2006. This requires certification to be provided with the application or a personal declaration pursuant to Presidential Decree n. 445/2000, for works published abroad the date and place of publication must be indicated.

6.Publications written in a foreign language must be accompanied by a certified Italian translation by official translator or consulate/embassy. The translation process is not required for publications written in French, English, German or Spanish.

#### **Art. 6 Renouncing Participation**

Candidates wishing to renounce participation in the selection procedure are required to write to the Rector to declare their intentions using the same modalities specified for application consignment, enclosing with their letter a photocopy of a valid identity document. Their renouncement shall be made official during the first meeting following receipt of renouncement.

#### **Art.7 Nomination of the Examining Board**

- 1.The Board, made up of three members of which at least two tenured professors and two from other universities, is appointed by Rector's Decree. One member must be chosen among high profile experts from a university or research center in another OECD country.
- 2.Individuals condemned for crimes even if not yet sentenced –in Book II, Title 2 of the Italian Penal Code ("crimes by civil servants against public administration") cannot be nominated.
- 3. At least 1/3 of the seats on the Examining Board must be reserved for women unless there is plausible and motivated cause making this impossible;
- 4. The Rector's Decree appointing the examining board shall be published on the University's Albo Ufficiale and on the university website.
- 5. From the date the Rector's Decree is published Candidates have 10 days, considering the urgent need to fill the positions, to file complaints or express opposition to any of the components of the board. After this period instances may no longer be presented.
- 6. Once the Board is formed the members nominate a President and a Secretary.
- 7. The board carries out its duties with the presence of all of its members and takes decisions unanimously.
- 8. Participation in all board activities is mandatory for members.
- 9. The Board, upon notifying the head of the selection procedure and receiving authorization from the Rector, may hold meetings using telematic technology. At the end of the meeting the minutes must be drawn up, approved, signed and forwarded to the competent administration office.
- 10. Expenses incurred may be reimbursed in accordance with the University's Regulations pursuant to art. 7 paragraph 4 in reference to the recruitment of fixed-term researchers

# **Art.8 Role and Duties of the Examining Board**

- 1.In the first session the Board, having determined that in compliance with related laws, no incompatibility factors are present, outlines the preliminary assessment criteria and procedures for selection in compliance with the parameters indicated in Ministerial Decree n. 243, 25 May 20011, in reference to qualification assessment and scientific publications (art.2 and 3 M.D. n.243). The commission also establishes an analytical system to confer points to candidates after preliminary assessment has been completed. The Board then establishes which candidates are admitted to the interview, together with the criteria for testing their English language skills, or Italian language skills (for foreign applicants).
- 2. The head of the selection procedure is immediately notified of the above mentioned results which are to be published on the University's Albo Ufficiale and on the website for at least 7 days before the Board can move on to the next phase of the selection procedure.
- 3.The above mentioned preliminary procedure initially involves determining if the candidates possess the requisites for participation, following this their CVs and publications, including their Ph.D thesis, are assessed.
- 4. Following preliminary assessment, the Board will select the most worthy candidates 10 to 20 percent of total candidates and no less than six in number to participate in a public discussion of their qualifications and scientific work; if the total number of candidates participating is 6 or less than 6 then they shall all be admitted to the oral discussion.
- 5.The list of candidates is drawn up by the Board indicating the results of the initial assessment procedure, together with indications as to date, place and time of the oral discussion and of English language assessment, published on the University's Albo Ufficiale and on the website at least 10 days before the oral discussion is to take place. This is to be considered an official notification for candidates. Candidates are required to appear for their interviews on the indicated date with a valid identity document. It is important to remember that candidates are not notified individually but only through the above stated notifications published online.
- 6. Following the oral discussion, the Board assesses the candidate's qualifications, attributes a grade to each publication and assesses interview and foreign language skills. Once this has been completed the Board draws up a ranking of the candidates and deliberates (by majority) the winner of the selection procedure. All the above results of the selection procedure are published on the University's Albo Ufficiale and on the website which to all effects represents an official notification for the participants in the selection.

7.All proceedings are contained in the minutes of the meetings, including all the assessment results obtained during the preliminary meeting, grading of qualifications and publications, oral discussion and assessment of English language skills.

#### Art. 9 Time Limits of the Selection Procedure

- 1. The Board is to conclude all necessary actions within four months from the date of the Rector's Decree nominating its members.
- 2. The Rector may extend the deadline only once and for no more than two months only in the case of exceptional and documented reasons brought forth by the President of the Board before the established deadline expires.
- 3.If all procedures are not concluded even within the extended deadline the Rector shall proceed to the substitution of the Board members, who become liable for the delays caused, establishing a new deadline for completion of the selection procedure.

#### **Art. 10 Determining Validity of Proceedings**

- 1. Within thirty days after the proceedings are consigned, the Rector issues a Decree establishing their validity, which is published on the University's Albo Ufficiale and on the website. **This, to all effects, represents official notification** and from that date candidates have a period of time to file a complaint. The selected candidate shall be notified by the Department offering the position.
- 2. If the Rector finds any irregularities in the proceedings he/she may make a motivated request to the Board to obtain rectification.

### Art. 11 Appointment by the Department

- 1.Within 60 days of the Rector's approval of the proceedings the Department Council that had requested the selection procedure must unanimously adhere to the decision and decide on a date to officially appoint the new researcher, to this end the Council must keep in mind the time needed to stipulate the contract. The Department's deliberation is subject to approval by the University's Board of Directors.
- 2. After the Board of Directors' approval which the researcher is invited to present all necessary documents for contract stipulation which must take place within 30 days.
- 3. If the winner renounces the position before signing the contract the Department may proceed to appoint the next candidate on the ranking list.

# Art. 12 Drawing-up of contract

A fixed-term full-time employment contract shall be drawn up and underwritten by the Rector, all elements regarding fixed-term researcher contracts specified in art. 10 of the University's Regulations must be indicated within said contract.

Given that the contract shall be pursuant to Leg. Decree n.165/2001 art. 53, it is important to state that it cannot be accumulated with other employment contracts, research grants, Ph.D or Specialisation courses, nor with any other earnings or grants from the University. As regards the researcher's duties the main duties established by law in reference to the category shall be applied. The researcher appointed will be required to abide by the University's Code of Behaviour, not doing so shall lead to termination of contract. The researcher shall also abide by norms regarding security, as established in Leg.
